Discussions & Resolutions:

The meeting started with Tamil Thai Vazhthu.

President Mr. Sudhakaran called the meeting to order and welcomed the gathering.

Secretary Mr. Mukesh initiated member allocation to EC members. The same will be completed within a week.

Discussion was started and EC members resolved matters as follow:

1. CAMS WhatsApp group status quo to be maintained. Only official communication related CAMS association like Minutes of meeting, messages related functioning of association, Advisors, Office bearers, EC members communication to and fro to members must be shared in this group.
2. CAMS EC WhatsApp Group – The communication between Advisors, Office bearers and EC members must be shared in this group.
3. CAMS Business Network WhatsApp Group – All business-related communication like advertisements, EDMs, Products and Price enquiries must be shared in this group.
4. CAMS Social WhatsApp Group – All wishes, condolences, jokes, Funs may be shared in this group.
5. All these groups are clubbed together in CAMS Association Madurai WhatsApp Community.
6. Messages shared in “CAMS Association Madurai Announcements” are very official and must be treated equal to messages shared in email groups CAMS-Madurai@googlegroups.com and ECCAMS-Madurai@googlegroups.com.
7. Members must not share any religion, politics and unethical messages in any WhatsApp and Email groups.
8. To lessen the financial burden of members member fees for the year 2025-2026 is fixed at Rs. 4,000/- + 18% GST without any change for the 4th consecutive year. Members are requested to pay the subscription on or before 30th June 2025.
9. Income tax filing will be done by Sai Services and Renewal of association registration will be done with the help of Mr. Senthil, Sensa Systems. In both these tasks Mr. T Pandiarajan agreed to help and co-ordinate with current team.
10. Mr. T. Pandiarajan Treasurer – 2024-2025 handed over Rs. 6,881/- as cash, unused cheque leaves of SBI account to Mr. A Muthuswamy, Treasurer. Bank balance will be shared once we receive the Account statement from the bank.
11. Mr. J Surender Secretary 2024-2025 handed over the association mandate books to Mr. E. Mukesh, Secretary.

12. Since Association registration was done by our former President and Core Committee member Mr. N. Senthilkumar, the original association registration certificate, PAN card and GST certificate are with him. For your information he had generously lended his office address too for our association.

Discussion and resolution on turf between Mr. A. Thirumaran Cricket Captain 2024-2025 and Mr. J. Senthilkumar President 2024-2025.

Mr. A. Thirumaran made a complaint that Mr. J. Senthilkumar President 2024-2025 removed him from CAMS WhatsApp group, without any notice. Mr. M. Saravanan, SMA computers advisor to CAMS 2024-2025 for himself and on behalf of his co-advisors 2024-2025 made complaint that the CAMS WhatsApp group setting was changed to "Only Admin can send messages" by Mr. J Senthilkumar. He further added that due to settings change in WhatsApp group, members were not able to share their views freely in CAMS WhatsApp group.

Mr. J. Senthilkumar, President 2024-2025 informed the floor that Mr. A. Thirumaran removed his and his co-office bearers' admin rights from official CAMS Cricket WhatsApp group on 23rd March 2025 itself, whereas his Presidentship was still active till 31st, March, 2025. Hence as a president Mr. J. Senthilkumar had taken action on Mr. A. Thirumaran and instructed his team to remove Mr. A. Thirumaran from CAMS WhatsApp group.

Mr. N. Senthilkumar, Adithya Computers, core committee member moderated the entire discussion to resolve the issue.

Previously Core committee member Mr. R. Saravanan ANT Systems, spoke over phone with Mr. A Thirumaran and Mr. J. Senthilkumar separately to bring an amicable solution, since, Mr. Thirumaran tagged him in an email asking for justice.

Core Committee members, Office bearers, Advisors and EC members had discussion and analysed the inputs received from both the parties and resolved the turf as follow:

It is indeed disrespectful to the entire CAMS members to remove the admin rights of sitting office bearers by Mr. A. Thirumaran, since the office bearers are elected in General Body of CAMS Association, and they must be respected.

CAMS office bearers 2024-2025, hastily and irresponsibly removed Mr. A. Thirumaran from CAMS WhatsApp group which was very wrong, since the office bearers are expected to be more responsible, courtesies towards their members.

As an association, as far as possible, we should not penalise any member but, need to cultivate the culture of brotherhood, encompassing a sense of shared loyalty, understanding, and friendship among members. Hence, the entire floor asked Mr. A. Thirumaran and Mr. J. Senthilkumar to shake hands as a gesture of togetherness. Mr. A. Thirumaran and Mr. J. Senthilkumar greeted each other with "Prarthana Mudra" and put a full stop to the turf. The entire floor was happy and praised both members.
